SUBCOMMITTEE BUSINESS

Elizabeth Brusati provided updates on California Invasive Species Action Week and suggested that Action Week's reach could be extended by CISAC's contacts. David Pegos recommended holding a CISAC subcommittee meeting to plan for next year's Action Week. David also introduced Corin Choppin who would be assisting CISAC as part of the California State University Sacramento facilitation contract.

The Outreach Subcommittee reviewed the meeting minutes for the May 25, 2023 Outreach and Education Subcommittee and approved it as amended.

David Pegos explained that CDFA is attempting to secure a contract with University of California Agriculture and Natural Resources to assist with the tour's travel logistics. The Subcommittee will form a working group including board members Shannon Lynch, Ted

Grosholz, Koren Widdel, Ricky Lara and Tom Smith. The working group will meet with CACs and develop draft tour routes for Subcommittee review. It was suggested that the routes include a mix of all six taxa, with fewer locations and longer stops allowing more face time and less travel time.
