Opening

The meeting of the California Invasive Species Advisory Committee (CISAC) Outreach and Education Subcommittee was called to order at 2:00 p.m. on August 7, 2023.

Shannon Lynch welcomed committee members, guests and staff.

Public Comments

No public comments were made by board members.

SUBCOMMITTEE BUSINESS

The Outreach and Education Subcommittee reviewed and approved the meeting minutes for the July 14, 2023 Outreach and Education Subcommittee meeting.

David Pegos updated the Subcommittee regarding efforts setting up a one-day tour in Shasta County through coordination with the Agricultural Commissioner and the UC Cooperative Extension office there. David Pegos noted that the Subcommittee currently has more clarity regarding the preparations around a Sacramento County tour. David Pegos will meet with the Orange County Agricultural Commissioner's office and the UC Cooperative Extension office in that county.

David Pegos also updated the committee on transportation preparations. The Subcommittee is coordinating with Ted Grosholz to secure two 55-passenger buses.

The Subcommittee reviewed a list of potential dates to hold invasive species tours gathered from a poll of the Subcommittee members' availability. David Pegos noted that, because the Subcommittee will tour Sacramento twice, the first Sacramento tour should be

scheduled for September 26th and the second tour should be scheduled for the 11th or 12th of October. October 11th would be preferable for attending legislators due to the legislative session scheduled for the morning of the 12th.

The Subcommittee will engage with the Agricultural Commissioners in Shasta and Orange Counties within the week to determine which of the available October dates would be best to hold a tour on in those respective areas. The Subcommittee will coordinate with Commissioner Flores' office and the UC Cooperative Extension office in Sacramento County to set up a meeting to prepare the details of the two Sacramento tours.
